THE PERIOD FOR WHICH PERSONAL DATA IS RETAINED

SHARING PERSONAL DATA WITH THIRD PARTIES

Prospectory will continue to bear ultimate responsibility for such processing operations.

COOKIES OR SIMILAR TECHNOLOGIES WE USE

Prospectory only uses technical and functional cookies and analytical cookies that do not infringe your privacy. A cookie is a small text file that is stored on your computer, tablet or smartphone when you first visit this website. The cookies we use are necessary for the technical functioning of the website and for your ease of use. They ensure that the website works as it should and that your preferred settings, for example, are remembered. It also enables us to optimise our website.
